1. The bid should be submitted in a sealed envelope superscribed as "Tender for Auction of Diplomatic Vehicle" and addressed to "Head of Chancery, High Commission of India, Dar es Salaam." The last date for submission of bids is 18th May 2026 . The bid must contain: (a) General Information as per Annexure-I (b) The Financial Bid as per proforma in Annexure II. Quotations must be valid for at least 90 days.
2. The bid will be confirmed in favor of the person quoting the highest rate for the vehicle.
3. The bids will be opened on 18th May 2026 at 1500 hrs.
4. The highest bidder must deposit 50% of the bid amount within three (03) working days of being declared the successful bidder.
5. The remaining 50% of the bid amount shall be deposited on or before the day of transfer of the vehicle and execution of the sale deed/documents. After full payment and completion of documentation, the vehicle will be delivered to the successful bidder, who shall be responsible for making their own arrangements to take delivery of the auctioned vehicle.
6. Conditional bids will not be entertained.
7. The High Commission of India reserves the right, at its discretion, to reject or accept any or all bids at any time without assigning any reason.
8. It shall be presumed that the bidder has fully inspected the Vehicle before the auction. The High Commission of India will not be responsible for and shall not entertain any complaint regarding any defect in the vehicle.
9. The officers and staff of the High Commission of India and their family members are not permitted to participate in the auction.
